In the reference 1st read above, orders were issued extending the validity of all Permanent/Temporary/Supernumerary Posts in the local, District, Zonal and Multi Zonal cadres situated in the geographical jurisdiction of the State of Andhra Pradesh, along with the State Cadre Posts allocated to the State of Andhra Pradesh by Government of India in accordance with the provisions of the Andhra Pradesh Reorganization Act 2014, until February 29, 2016. In the reference 6'h read above, orders were issued for further continuation of the said posts till March 31, 2020.

- 2. Keeping in view of the necessity for further continuation of the posts, the Government hereby order that all posts would be continued up to July 31, 2020. Similarly, all posts created/upgraded/modified to the overall establishment of Andhra Pradesh Government on or after March 31, 2020 are also hereby ordered to be continued until July 31, 2020.
- 3. The continuation orders issued in paragraph-2 above shall not apply to the outsourcing/Contract posts that might have been sanctioned along with the regular posts in the same Government Orders.
