#### **SCHEDULED CASTES COMPONENT**

The Budgetary Classification System provides normative frame work for both policy Formulation and Accountability. Hither to the Government have been following Plan & Non-Plan system of Classification. Now, as per the decision of the Government of India, to merge Plan & Non-Plan expenditure and Classify the Government expenditure under Capital and Revenue, the budget allocations are made accordingly.

As the distinction between Plan & Non-Plan has been removed and there is no Plan from the fiscal year 2017-18, the allocation for the Scheduled Castes Component are based on percentage of total schemes allocation for both Centrally Sponsored Schemes and State Government schemes and by duly ensuring that the allocation to the Scheduled Castes Component will not be less than the percentage of SC Population.

On these lines, Budget allocation for 2018-19, is made for the schemes which would secure direct and quantifiable benefits to Scheduled Castes Individuals or Scheduled Castes Habitations.

An amount of Rs.1122810.59lakhs, has been allocated under Scheduled Castes Component 2018-19. A brief summary of Financial allocation under Scheduled Castes Component 2018-19 is given below.

#### 1. AGRICULTURE DEPARTMENT:

- **(i) RashtriyaKrishiVikasYojana (RKVY)**:RashtriyaKrishiVikasYojana (RKVY) is one of the Flagship Programmes of Govt. Of India with 60% share from Central Govt. and 40% State share for holistic development of Agriculture and Allied Sectors, (Agriculture, Horticulture, Animal Husbandry, Fisheries, Sericulture etc.) for implementation of priority based various projects as per the approval of State levelSanction Committee to maximize the returns to the farmers.
- (ii) National Food Security Mission (NFSM): The National Food Security Mission scheme launched by Government of India with 60% subsidy from Central and 40% from State. The main objective is increasing production of Rice, Wheat, Pulses and Coarse Cereals through area expansion and productivity enhancement in a sustainable manner in the identified Districts of the Andhra Pradesh. The interventions to be implemented under NFSM are, accelerated Crop Production Programmes (cluster Demonstrations), need based inputs (Seeds distribution, INM, IPM, PP Chemicals, farm machines and implements, irrigation devices, capacity building, PMT and local initiatives) and need based area specific technologies.
- (iii) National Mission On Oilseeds & Oil Palm (NMOOP): To increase Production and Productivity of Oilseeds and Oil palm and to bring additional area under Oil palm cultivation by utilization of wastelands with 60% subsidy from Central and 40% from State. This mission has two submissions. Mini Mission (MM-I) on Oilseeds is implemented by the Agriculture Department. The Mini Mission on Oilseeds envisages increase in Production of vegetable oils sourced from Oilseeds.
- (iv) National Mission on Agricultural Extension & Technology (NMAET): It has 3 sub missions. Implemented with 60% financial assistance from Central and 40% from State.
  - **(a).Sub Mission on Agriculture Extension (SMAE):**It has the key responsibility of disseminating all technology activities at the district level. It has linkages with all the line departments, research organizations, non-governmental organizations and agencies associated with agricultural development in the district and farmer organizations.
  - **(b).Sub Mission on Agricultural Mechanisation (SMAM):** Farm Mechanization, ensures reduction of drudgery associated with various farm operations and also economize the utilization of inputs and thereby harnessing the potential of available resources. The cost of cultivation is being escalated every year resulting in narrowing the net profit. Among many reasons, cost & availability of labour contributing to the

increase in the cost of cultivation. Mechanization of feasible farm operations will address the problem to the maximum extent.

- **(c).Sub Mission on Seed & Planting Material (SMSP):** Covers strengthening of seed testing labs, seed farms, Certified seed production through SVP, transport subsidy, seed storage, seed processing plants etc.
- v). National Mission For Sustainable Agriculture (NMSA): It consists of 2 Sub-Missions.
  - (a). Rainfed Area Development Programme (RADP): Increase of Horticultural based area in Rainfed districts by adoption of efficient water management system by supplying water carrying pipes, creation of water storage structures and soil and moisture activities. Funding pattern 60:40 (central and state share)
  - **(b) Soil Health Card Scheme:** The objective of the Scheme is to issue soil health cards to farmers covering all the land holdings. The total land holdings/farmers will be covered once in every three years.

As per the guidelines of GOI the sharing pattern of funds for implementation of scheme is 60:40.

#### vi) ParamparagatKrishiVikasYojana:

- Promotion of Organic Farming in clusters under PGS (Participatory Guarantee System).
- In each cluster 300 farmers are identified to adopt exclusively Organic/ Natural farming in Kharif.
- In each cluster 1MPEO, 1 Cluster Activist (CA), 2 Community Resource Persons (CRPs) & 30 Master farmers will act as a team to promote natural farming in the clusters.
- 231 Farmer Experts who are the best practicing farmers, work for 18 21 days in each round and train farmers on need based inputs i.e., preparation of botanical extracts, Ghana/Drava Jeevamrutham etc., and promote NADEPs, SRI cultivation, RFSA methods etc.
- To meet the immediate requirement of farmers, the 300 farmers in the cluster are provided assistance as follows.
  - a. Establishment of NPM shops @ 5 per cluster on 50% subsidy @Rs.50,000/-unit
  - b. Procurement of Cows @ 30 per cluster on 50% subsidy limited to Rs.10000/-unit.

#### vii) Prime Minister FasalBimaYojana:

It is a Crop Insurance scheme. Farmers premium contribution in Kharif 2% and in Rabi 1.5% for Food crops and Oil seed crops. It covers damages due to inundation apart from Hail storm and Post harvest crop damage. Uses technology for assessment of Area/yield for quicker settlement of claims.

- **viii) Farm Mechanisation:** Agricultural mechanization helps in increasing production, productivity and profitability in Agriculture by achieving timeliness in farm operations. Farm equipment like land preparatory, sowing equipment, plant protection equipment etc., are supplied under subsidy. Custom Hiring Centres and Implement Hiring Stations are also introduced in mandals for major crops grown in the state like Paddy, Maize, Ground nut, Cotton and other crops like Tobacco to make High cost machinery available to small and marginal farmers.
- **ix) Extension:** The Scheme covers capacity building of farmers, farm women and farmer groups through farmer trainings, PolamPilusthondi to upgrade skills and knowledge through transfer of technologies to address the production gaps. Strengthening of RMGs to function as the interface between the Agricultural Extension system and Farmers for transfer of technology, access to market information and other farm related advice.
- x) Integrated Nutrient Management: Analysis of soil samples has indicated that 40-49% of soils in Andhra Pradesh are potentially deficient in Zinc, Iron, Manganese and boron. It is evident that 10-20 % of the yield will be increased due to correction of Micro Nutrients deficiency by application of micro nutrients to the soils. Under INM programme mainly Zinc Sulfate and other micro nutrients is supplied to enhance Agriculture productivity through soil test based application. The fertilizer control labs are also strengthened. To increase productivity, it is planned to supply required quantities of micronutrients to farmers on 100% subsidy. In addition to soil application foliar application is also proposed to correct the micronutrient deficiency.
- **xi) PavalaVaddi:**PavalaVaddiis a bank linked scheme to provide financial support to the farming community and to encourage the farmers for timely repayment of crop loans. PavalaVaddi is applicable for crop loans for the loan amount more than Rs.1.00 lakh and upto 3.00 lakhs.
- **xii) Polambadi:**The main objective of Polambadi is to reduce the cost of cultivation and increase the productivity duly empowering the farmers to take economical decisions by adopting practices of integrated crop management. The Polambadi programme is organized by MAO and AEO in crop period from seed to seed for 14 sessions/ weeks in 10ha of land for 30 number of farmers in each Polambadi unit.
- **xiii)** Chandranna Rythu Kshetralu: Chandranna Rythu Kshetram is the onfarm demonstration programme implemented in the farmer's field itself, to promote best agronomic and farm management practices for achieving increase in productivity and reducing the cost of cultivation.
- **xiv) Soil and Water conservation programme:** The main objective is to retain the moisture for longer period and also to increase the productivity through soil conservation measures.

Agriculture sector will be focussing on following strategies for achieving double digit growth as part of "Swarnandhra Vision-2029", which would go a long way in the economic development of the Scheduled Castes farmers.

- Soil Health Management.
- Correcting micronutrient deficiency in major crops on machine mode.
- New seed varieties
- Popularisation of Farm Mechanization with dew importance for custom Hiring centres.
- Training and awareness programme through Polam Pilusthondi.
- Demonstration of low cost, high productivity technologies to farmers through Chandranna Rythukshetralu.
- Promotion of inter cropping.
- Promotion of poly cropping.
- Increasing the Redgram area through inter cropping and growing on Rice bunds.
- Promotion of Organic farming and millet cultivation.
- Adopting drought protection measures.

An amount of Rs. 44482.39 Lakhs is allocated in 2018-19 to Agriculture Department.

#### 2. HORTICULTURE DEPARTMENT:

#### i) PradhanaMantriKrishiSinchaiYojana (PMKSY) APMIP:

The objective of the programme is to enhance the crop productivity by improving the water use efficiency through Micro Irrigation systems for the benefit of the farmers.

In view of deficit Rainfall, Rain shadow regions, unpredictable rains and considerable depletion of ground water there is no option for farmers except going for Drip Irrigation. To achieve the concept of "More crop per Drop " Micro irrigation is to be taken up particularly in the Districts of Rayalaseema, which are most back ward areas, apart from other back ward areas in Andhra Pradesh. icro Irrigation is being implemented under PMKSY with funding pattern of 60:40 between Central and State Government.

## ii) Mission for Integrated Development of Horticulture (MIDH): (National Horticulture Mission)

A Centrally Sponsored Scheme – National Horticulture Mission (NHM) is implemented in the State by the State Horticulture Mission. The focus of the programme is to provide comprehensive development of all the sub-sectors of Horticulture so as to provide additional income to Horticulture growers. This programme is under implementation in 9 districts (Srikakulam, West Godavari, Guntur,

Prakasam, SPS Nellore, Chittoor, YSR Kadapa, Ananathapuramu, and Kurnool) and two tribal areas of Rampachodavaram of East Godavari andPaderu of Visakhapatnam districts. Andhra Pradesh, with its high growth trajectory, a large population, significant dependence on agriculture and Horticulture and an extensive coastline is likely to become a significant player in production and marketing of Horticultural produce.

Later, this programme was renamed as "Mission for Integrated Development of Horticulture (MIDH)" and is implemented w.e.f April 2014 by subsuming six schemes on Horticulture Development including NHM as per the revised cost norms and pattern of assistance.

The major components covered under MIDH are a) Area Expansion (Perennial and Non-Perennial crops), b) Rejuvenation of senile orchards, c) Protected Cultivation, d) Post Harvest Management, e) Creation of Water Resources (Farm Ponds) f) Farm Mechanization and g) Capacity Building.

## iii) National Mission on Oil Seeds and Oil Palm Programme (NMOOP)Mini Mission-II:

Andhra Pradesh ranks 1<sup>st</sup> in cultivation of Oilpalm with 1.49 lakh Ha with 1.04 lakh farmers in 8 districts of Andhra Pradesh spreading over in 225 mandals.

13 Processing units were established by Oil Palm Companies with Capacity of 240 MT/Hr., which are working with Government under this programme.

#### iv) Promotion of Horticulture Activities:

In Andhra Pradesh under Primary Sector Mission lot of emphasis has been given to Horticulture sector as it has been identified as best growth engine for overall development of the primary sector. Many innovative schemes like Area Expansion, Canopy Management in Cashes etc taken up.

An amount of Rs. 27834.42 Lakhs is allocated in 2018-19 for Horticulture Department.

#### 3.SERICULTURE:

Sericulture is an agro-based cottage industry providing employment to the rural folk especially to women/youth and playing a vital role in up-liftment of the rural economy. It generates an average income of Rs.1,25,000/- per acre per annum. It is estimated that Sericulture can generate employment @ 11 man days per kg of raw silk production (in on-farm and off-farm activities) throughout the year. Andhra Pradesh is the Second largest Raw silk producer in India.

The following programmes will be taken up during 2018-19,

Supply of High Yielding Variety saplings,

- Construction of rearing sheds to SC farmers
- Supply of rearing appliances to SC farmers
- Farm mechanization
- Assistance to farmers on cost of BivoltineChawkie Charges to SC farmers
- Assistance for Organic farming

An amount of Rs. 249.32 Lakhs is allocated in 2018-19 for Sericulture Department.

#### 4. ANIMAL HUSBANDRY:

The following schemes are implemented.

#### **Integrated Live Stock Management:**

#### i) Heifer induction and rearing programme:

A scheme designed to develop replacement of breeding stock through heifer induction followed by rearing support to reduce the age at first conception in female cattle. The elite heifer's will be inducted and enrolled in the first year of the programme and support will be given for insurance, feed, fodder, health care and other support activities up to the age of 28 months in case of cross breeds or 36 months in case of buffaloes or till the date of calving whichever is earlier. Unit cost of heifer is Rs.60,000/- with 75% subsidy of an amount Rs.45,000/- support by the Animal Husbandry Department and remaining Rs.15,000 is supported by Strinidhi to the beneficiary as loan component.

Beneficiary identification, identification of the pregnant heifer and grounding is done by the Animal Husbandry Department.

The additional milk production in the state is estimated to be 0.15 LMTs after complete implementation of this programme and to create the milch animal replacement stock.

#### ii) Feeding support to animals owned by SCs:

The animals owned by SCs will be given feed and fodder support on subsidy basis as per the policy of the AH department providing the Silage cost is provided with 75% subsidy with Rs.2/-/Kg silage as beneficiary contribution, Hydrophonics with 75% subsidy is given to farmers, TMR is given with 75% subsidy with Rs.3.50/- as beneficiary contribution.

#### iii) Ongole Male calf rearing:

To conserve Ongole breed of cattle and as income generating activity to SHG it is proposed to encourage rearing of male Ongole cattle involving SHG group in the breeding tract with 90% subsidy. It is proposed to implement this activity in Ongole cattle breeding

tract in the state. Implemented only in Prakasam and Guntur districts with a unit cost of Rs.43,900/- with 90% subsidy. The scheme is benefited to farmers by generating additional income by direct selling or could be used for draught power utilized in agriculture and cart pulling.

#### iv) Pregnant and lactating animal care (Kheerasagar):

It is a scheme designed to reduce inter calving period in milch animals, so that the life time milk production from the animals treated will get increased.

The insurance, feed support and other logistics will be given for a period of six months (Last 3 months of pregnancy and first 3 months of lactation). To reduce the inter calving period in cattle from 24 months to 18 months with better nutrition and create additional 360 litres of milk and one calf extra can be obtained from each animal in its life time.

The unit cost of the scheme is of Rs. 9390/- with 90% subsidy supported by the Animal Husbandry Department.

#### v) Calf rearing Scheme (Sunandini):

It is a scheme designed to develop replacement of breeding stock within the state instead of animal induction and to reduce the age at first conception in female cattle. The elite female calves at the age of 4-6 months will be enrolled in the first year of the programme and support will be given for feed, health care and other support activities up to the age of 28 months or till the date of calving whichever is earlier. Only heifer calves owned by SC families will be enrolled and given support of 75% subsidy in the unit cost of Rs.11590/- on inputs and insurance cost for a period of 2 years.

(870) kg of protein rich concentrate feed will be supplied to the enrolled calves over a period of two years. Periodical deworming together with mineral supplementation will also be given apart from providing medicines for calf scours or any other infection under health coverage. Orientation programme will be organized for the selected beneficiaries on calf feeding and management.

The support for 2<sup>nd</sup> year will also be continued for the calves already enrolled earlier based on specific proposals received from districts.

The additional milk production in the state is estimated to be 0.30 LMTs after complete implementation of this programme.

#### vi) Fertility Management of animals owned by SC:

After calving, the milch animals are required to be managed for ideal service period. When management of animals for reproductive healthcare is taken care of, ideal service

period can be maintained in animals so that the milch animals can give more calves during its life time by conducting the fertility camps with unit cost of Rs.42,900/-.

#### vii) Manakodi:

Rural Backyard Poultry offers excellent scope to improve nutritional status and financial support to the SC families in rural areas. The scheme will be implemented as per the norms of GOI. It is proposed to implement the programme to support (2000) SC families below poverty line in the state. Each Rural Backyard Poultry unit consisting of 45 one month old vaccinated chicks consisting of same number of male and female chicks with unit cost of Rs.4660/- with Rs.3750/- subsidy (includes night shelter) and Rs. 810/-as beneficiary contribution.

#### viii) Production of embryos, implantation & propagation of heifer rearing:

Embryos will be implanted in the Surrogate cows of the breeders. Cost for implantation of embryos Rs.22,000/-.Calf produced from this surrogate mother reared for 18-24 months by the breeders for supply to the SC beneficiaries. The first calf will cost Rs.80,000/- Total Rs.80,000/- will be a subsidy component.

By this elite healthy heifers at 1½ to 2 years age are available to the SC farmers with free of cost.

## ix) Promotion of Indigenous animal rearing in cluster through establishment of Animal Hostel involving NGOs/FPOs

The scheme allows maintenance of the local animals available in the village collectively in a farm with a maximum unit size of 100.

An amount of Rs. 6500.00 Lakhs is allocated in 2018-19 for Animal Husbandry Department.

#### 5. FISHERIES DEPARTMENT:

The following schemes are implemented under the Scheme for Relief and Welfare of Fishermen belonging to Scheduled Castes.

#### i). Assistance to Retail Fish marketing by supply of Cycle with Nets and Ice boxes

The objective of the scheme is to provide Cycle with nets and ice box to active fishers to support and enhance their livelihood and also to create employment opportunities.

**Unit Cost and Pattern of Assistance:**The unit cost of all these three items is fixed at Rs.15, 000/- depending on the type of Cycle, ice box and nets. The subsidy will be 90% of the

unit cost or actual cost whichever is less with a maximum ceiling of Rs.13,500/-. The balance 10% of unit cost will be beneficiary contribution or bank loan.

## ii). Supply of two wheelers with ice box/ Freezer mounted Mopeds for fish vending/ two wheelers with ice box for shrimp seed transport:

The Objective of the Scheme is to increase domestic fish consumption, to supply fish to consumers in hygienic and fresh conditions and to supply the shrimp and fish directly to processing units thereby improving livelihoods.

**Unit Cost and Pattern of Assistance:** The unit cost not exceeding Rs.0.60 Lakhs depending on the requirement of trade. The subsidy will be 90% of the unit cost or actual cost of the unit whichever less subject to maximum ceiling of Rs.0.54 Lakhs is. The balance 10% of unit cost will be beneficiary contribution or bank loan.

#### iii). Assistance to Retail Fish marketing by supply of Three Wheelers with Ice boxes

The objective of the scheme is to increase domestic fish consumption, to ensure access of the poor to nutritious food, to supply fish to consumers in hygienic and fresh conditions besides improved livelihoods

**Unit cost and Pattern of Assistance:** The unit cost is Rs.3,00,000/-. The subsidy shall be 90% of the unit cost or actual cost whichever is less subject to maximum ceiling of Rs.2.70 Lakhs. The balance 10% of unit cost can be beneficiary contribution or bank loan.

#### iv). Assistance to Retail Fish marketing by supply of Four Wheelers with Ice boxes

The Objectives of the scheme is to increase domestic fish consumption, to ensure access of the poor to nutritious food and Supply fish to consumers in hygienic, and fresh conditions

**Unit Cost and Pattern of Assistance:** The unit cost of Four wheeler including accessories should not exceed Rs. 4, 40,000/-. The subsidy shall be 90% of the unit cost whichever less subject to maximum ceiling of Rs.3.96 Lakhs. The balance 10% of unit cost can be beneficiary contribution or bank loan.

#### v). Supply of Ice boxes to Fishers:

The Objective of the Scheme is to sell the fish in fresh and hygienic condition where the sellers will get good price and the consumer will get quality fish.

**Unit Cost and Pattern of Assistance:** The unit cost of ice box (100 liter) will be Rs.6000.00. The subsidy shall be 90% of the unit cost i.e., Rs.5400/unit or 90% of the actual cost of the

unit whichever is less. The balance 10% of unit cost will be beneficiary contribution or by bank loan.

#### vi). Assistance for Establishment of Fish retail Kiosk

The Objective of the scheme is to increase domestic fish consumption, to popularise the modern fish processing and preservation technologies, to ensure access of the poor to nutritious protein food, to make available the supply of hygienic fish to consumers in fresh conditions and to increase the per capita fish consumption.

**Unit Cost and Pattern of Assistance:** The unit cost will be uptoRs. 10, 00,000/-. The subsidy shall be 90% of the unit cost or actual cost whichever is less with a maximum ceiling of Rs.9.00 lakhs. The balance 10% of unit **cost** can be beneficiary contribution or bank loan.

#### vii). Supply of Fish seed transport vans

The objective of the scheme is to provide assets by supplying fish seed transport vans to support their livelihood.

**Unit Cost and Pattern of Assistance:** The unit cost is fixed up to Rs.10.00 lakhs depending on the type of van. The subsidy will be 90% of the unit cost or actual cost whichever is less subject to maximum ceiling of Rs.9.00 Lakhs. The balance 10% of unit cost will be beneficiary contribution or bank loan.

A total amount of Rs.5931.00lakhs is allocated in 2018-19 to Fisheries Department.

#### 6. PRINCIPAL CHIEF CONSERVATOR OF FORESTS:

National Afforestation Programme and Sub Mission on Agro forestry (SMAF) programmes are implemented.

An amount of Rs.414.99 lakhs is allocated in 2018-19.

#### 7.TECHNICAL EDUCATION DEPARTMENT:

The Department will take the activities such as construction of new Hostel buildings for Scheduled Caste Students in existing 14 Government Polytechnics and construction of hostel buildings for SC Students in the existing Government Model Residential Polytechnics in Rajamahendravaram and Madanapalli, and to meet the amenities in GMR Polytechnics.

An amount of Rs.519.75lakhs allocated during 2018-19.

#### **8.COLLEGIATE EDUCATION DEPARTMENT:**

The Department will takeup the activities such as student interactive programmes such as group discussions, participating in seminars, conducting study projects etc. Infrastructure facilities to the two colleges sanctioned under SCC. Text books will be provided to the SC students studying in Degree Colleges. Construction of Hostels in Residential Degree Colleges will be taken up.

An amount of Rs.2036.23lakhs allocated during 2018-19.

#### 9. ENERGY DEPARTMENT:

Progrmmes likes electrification of Dalithbastis, Energisation of borewells and providing two more LED bulbs to SC Households are implemented under SCC.

An amount of Rs.15800.00 lakhs is allocated in 2018-19

#### **10.SCHOOL EDUCATION:**

The Department will utilise the budget for meeting the cooking cost of the midday meal to take up activities such providing quality education by organising excursion trips, supply of study kits for maths, conducting motivation camps for girl students and providing training to girls for self-defence etc.

#### i) SARVA SHIKSHA ABHIYAN (SSA):

SarvaShikshaAbhiyan is a centrally sponsored scheme being implemented in the state since 2001-02 to attain Universal Elementary Education. SarvaShikshaAbhiyan, Andhra Pradesh is the implementing society for SarvaShikshaAbhiyan. After passage of RTE Act, SSA has been identified as main vehicle to implement the provisions of the Act. Government of India and State Government release funds, as per the ratio fixed by Government of India from time to time.

- All children in school, Education Guarantee Centre, Alternative School, Back-to-School camp.
- All children complete eight years of elementary schooling.
- Focus on elementary education of satisfactory quality with emphasis on education for life.
- Bridge all gender and social category gaps at elementary education level
- Universal retention.

#### Interventions:

- Civil Works Construction of School Buildings, Addl. Classrooms, MRC Buildings, Rooms for School Complexes, Toilets, Electrification & drinking water facilities.
- Release of Maintenance grant to Schools with own buildings.
- Release of School Grants & Teacher Grants for all schools.
- Training to Teachers with special emphasis to the schools located in SC areas for improving quality of the teaching.
- Supply of two pairs of uniforms to the children studying in Government schools upto 8<sup>th</sup> class every year.
- Special camps are being organized in Schedule Castes areas to cover the Out of School Children.
- **ii) Rashtriya Madhyamika ShikshaAbhihyan (RMSA):**It is an Centrally Assisted State Development Programme with funding pattern of 60% from Central Govt and 40% from State Government.

Through this programme infrastructural facilities will be strengthened at Secondary and Higher Secondary stages. Assistance is provided to the inputs leading to quality education such as suitable curriculum, learning resources, teachers, academic support, teaching-leaning process, monitoring, evaluation and supervision.

An amount of Rs.51958.19 lakhs is allocated in 2018-19.

#### 11.ADULT EDUCATION:

Basic literacy programme covering 1,00,000 learners in the age group of 15 years and above, Non-literates among the Scheduled Castes is implemented.

An amount of Rs.1682.70 lakhs is allocated in SCC 2018-19.

#### **12.INTERMEDIATE EDUCATION DEPARTMENT:**

The Department will take up the activities such as supply of text books to SC students studying in Govt/Aided colleges at free of cost. Construction of additional class rooms and accommodation in needy Government Jr Colleges where the SC student strength is more than 40 %. And also taking construction of attached hostels in needy Government Jr Colleges where the SC student strength is more than 40 % to facilitate the students.

An amount of Rs.1093.00lakhs allocated in 2018-19

#### 13.FOOD AND CIVIL SUPPLIES DEPARTMENT:

An Amount of **Rs.1200.00Lakhs** is allocated for the year 2018-19 for distribution of LPG Connections to women in rural areas / municipal Areas.

#### **14. MEDICAL EDUCATION DEPARTMENT:**

National programme for prevention and management of Burn injuries and construction of State Cancer Institute will be taken up.

An amount of Rs.0.39 lakhs is allocated in 2018-19.

#### 15 .PUBLIC HEALTH AND FAMILY WELFARE DEPARTMENT:

Medicines will be provided to the poor urban/rural SC patients.

An amount of **Rs.6500.00 lakhs** is allocated in 2018-19 towards Centralised Purchase of Drugs and Medicines.

#### **16.FAMILY WELFARE DEPARTMENT:**

The Department will take up the activities such as National Health Mission (NHM) programmes which contain RCH Flexi pool and Mission Flexi pool.

In RCH Flexi pool major components are Maternal Health, Child heath, Family Planning, RBSK,RKSK, Training, HR,Programme Management etc.

In Mission Flexi pool, the major components are ASHA, Hospital Strengthening, new Constructions, Spill over constructions etc.

In immunisation the components are routine Immunization, strengthening Project, Cold Chain Maintenance, ASHA incentive etc. In Communicable DiseasesProgramme thecomponents are IDSP, NVBDCP, NLEP, RNTCP. The non Communicable Diseases Programme consisting of NTCP, National programme for prevention and control of cancer, Diabetes, Cardio Vascular disease and stroke, National Trachoma & Blindness Control Programme National Health Mission Programme.

**CHANDRANNA SANCHRA CHIKISTHA:** The habitations which are 3 KMs away from the Primary Health centre are covered by the ChandrannaSanchraChikistha – affixed day health service programme at the door steps of the rural people for providing the health services by the team of Doctor, Staff nurse, lab technician, pharmacist and pilot shall visit the villages and attend the health services to the chronic patients and ante natal mothers. They shall visit on a fixed day in a month and shall dispense all the required drugs for a period of one month if required and also conduct all required tests for diagnosis.

**REHS-108 Services:** in order to provide Emergency Health Care services to the people met with accidents, ante natal mothers and other fatally ill patients. The services are providing the golden hour opportunity for treatment of critically ill patients duly transporting them to the designated hospitals and saving thousands of lives.

**Janani SurakhshaYojana:**To encourage institutional deliveries and to decrease IMR & MMR, an amount of Rs.700/- and 300/- per Rural Pregnant women who comes for delivery to the Govt. Institutions will be paid as incentive and wage compensation. The SC women are availing services.

**Basavatharakam Mother Kits**: "Basavatharakam Mother Kit" will be given to the mothers who deliver in government institutions in Andhra Pradesh to reduce maternity morbidity. Kit cost is Rs.800/- per kit.

An amount of Rs.25305.72 lakhs is allocated during the year 2018-19

#### 17.AYURVEDA, YOGA, UNANI, SIDDHA AND HOMEOPATHI (AYUSH) DEPT:

Cultivation of medicinal plants through subsidy component, Raising of nurseries etc., will be taken up.

An amount of Rs.949.53 lakhs is allocated in 2018-19.

#### **18.DIRECTOR GENERAL & INSPECTOR GENERAL OF POLICE:**

An amount of **Rs.100.00Lakhs** is proposed for the year 2018-19 towards Capacity Building of Police Personnel on POA Act implementation.

#### 19. WEAKER SECTION HOUSING DEPARTMENT:

The A.P. State Housing Corporation Ltd is implementing the following housing programmes to the Weaker Sections in the state under SCC during the year 2018-19.

- i) NTR Rural Housing,
- ii) NTR Rural housing dovetail with Pradhan MantriAwaasYojana (Gramin) & MGNREGS.

#### 22.INDUSTRIES, COMMERCE AND EXPORT PROMOTION DEPT:

The Department of Industries has been extending Financial Assistance to SC Entrepreneurs in the form of incentives namely investment subsidy, reimbursements of allowable percentages towards stamp duty, land cost, land conversion charges, power cost, interest subsidy (PavalaVaddi) and sales tax etc.,

An amount of Rs.20740.00lakhs is allocated for the year 2018-19.

#### 23.INFORMATION TECHNOLOGY, ELECTRONICS & COMMUNICATIONS DEPT:

The Department will take up the following activities.

- a) Positioning of teams of IT professionals for Project Management Unit (PMU) in Directorate and Secretariat of SW Dept., for monitoring all IT initiatives, Biometric attendance, monitoring software
- b) Maintenance of existing computer hardware, Biometric devices, TVs, RoTsetc
- c) Providing computer laboratories and virtual class rooms in SW Residential Institutions and their content maintenance.
- d) Digital literacy and enhancement of employment of SC youth.
- e) Procurement of new Computer hardware, Biometric systems, software, connectivity and up-gradation.

An amount of Rs.2804.40 lakhs allocated for the year 2018-19.

#### **24.EMPLOYMENT &TRAINING:**

An amount of **Rs.2584.03lakhs**is allocated for 2018-19. The amount will be utilized for providing diet charges, cosmetics, tool kits, raw material etc., to the SC students of two RITIs at Macharla & Kadapa, to impart quality training.

#### **25. LABOUR DEPARTMENT:**

"ChandrannaBima", a Social Security Scheme is to provide relief to the families of unorganized workers in case of death or disability of the unorganised worker leaving the families in great distress. An amount Rs.5.00 Lakhs (Rupees Five Lakhs only) is provided for accidental death and disability Insurance.

An amount of Rs.2394.00 lakhs is allocated in 2018-19.

#### 26.MUNICIPAL ADMINISTRATION AND URBAN DEVELOPMENT DEPT, SECTT:

#### **Providing infrastructure facilities in Scheduled Caste localities of ULBs:**

The Scheme is to fill the infrastructural gaps in Scheduled Caste localities in the Urban Local bodies in the State such as laying of roads and drains, providing drinking water supply pipe lines, construction of community halls, providing street lighting facilities etc.

An amount of Rs.67356.82 lakhs allocated in 2018-19.

#### **27.MUNICIPAL ADMINISTRATION DEPT:**

The Department will takeup the following activities.

#### i) Assistance to Municipalities under State Finance Commission:

The scheme aims at providing basic amenities in the SC localities in the Urban Local Bodies in the State

#### ii) Assistance to New Municipalities / Corporations for Developmental Works:

The scheme is to provide basic amenities such as laying of roads and drains, providing drinking water supply pipe lines, construction of community halls, providing street lighting facilities etc in the SC localities in the Urban Local Bodies in the State.

**MEPMA:**To enable the Urban poor particularly the poorest of the poor to come out of poverty and vulnerability in a sustainable manner and improve their quality of life in Urban areas through their self managed and self reliant institutions. The following programmes are taken up:

- a) **Livelihood Enhancement**: Community Investment Fund, Pavalavaddi, VaddiLeniRunalu, StreeNidhifund, Employment generation for educated urban youth andproviding livelihoods.
- b) **Human Development**: Health & Nutrition for women and children, Education for rural children, Inclusive development for persons with disability, Addressing Gender Issues Insurance and social security.

An amount of Rs.7760.00 lakhs allocated in 2018-19

#### **28.PLANNING DEPARTMENT:**

An amount of **Rs. 17700.00 lakhs**is allocatedin 2018-19 for Special Development Fund for welfare and development activities in the Scheduled Castes areas of the State.

#### **29.PANCHAYAT RAJ ENGINEERING DEPARTMENT:**

Works like Approach Roads, Internal, CC Roads, Drains are taken up under CRR, Upgradation of NREGS and NABARD (RIDF) schemes by the Panchayat Raj Engineering Department in SC Habitations/ Colonies.

It is proposed to complete the spill over road works sanctioned, including theroad works sanctioned to un-connected SC Habitations with population more than 250.

An amount of Rs.37935.00 lakhs proposed for allocation during 2018-19.

#### **30.RURAL DEVELOPMENT DEPARTMENT:**

The following schemes are implemented under SCC 2018-19.

#### i) MGNREGS:

It is to provide not less than one hundred days of unskilled manual work as a guaranteed employment in a financial year to every household in rural areas as per demand, resulting in creation of productive assets of prescribed quality and durability. Development of social infrastructure, land development activities, individual beneficiary oriented works are takenup.

#### ii). Pradhan MantriKrishiSinchayeeYojana (Watersheds – ertstwhile IWMP):

Harnessing, conserving and developing degraded natural resources, increase in agricultural production through scientific approach, integrated livestock management, livelihood security for the poorest SC rural people are the main activities under the scheme.

#### iii).NTRJalasiri:

The scheme essentially focus on utilisation of available ground water resources and to promote conjunctive use of surface water and ground water by adopting water intensive irrigation technics like drip/sprinkler.

#### iv) A.P.SERP

The following schemes are implemented by the APSERP under SCC 2018-19

- a).NTR Bharosa OAP & Widow Pensions Rs.1000/- per month is provided to poor old age persons/Widows.
- b). NTR Bharosa Disable Pensions Rs.1000/ Rs.1500 per month is provided to the disabled persons having minimum of 49% disability.
- c).Insurance/Pension Scheme to DWACRA Women (Anna AbhayaHastam) It is a co-contributory pension and life insurance scheme for SHG women. SHG Women contributes Rs.1/- per day and Govt co-contributes Rs.1/- per day. Minimum pension of Rs.500/- to women on crossing 60 years of age till death is assured.
- d). Assistance to Andhra Pradesh MahilaSadhikaraSamstha (APMSS) activities related to livelihoods, strengthening of SC SHGs etc., are takenup under the scheme.
- e). National Rural Livelihood Mission (NRLM)—bringing all left over SC community members into SHG fold, revival and strengthening of C and D Grade SHGs, financial literacy to SHGs etc are the activities under this programme.

An amount of Rs.171597.28 lakhs is allocated to Rural Development Department in 2018-19.

#### **31.RURAL WATER SUPPLY DEPARTMENT:**

The department is responsible for providing infrastructure for supply of drinking water and construction of sanitation facilities in habitations in Rural Areas.

Safe Drinking Water Supply is a very important issue as over 80% of health problems are due to consumption of unsafe water. Because of increasing health awareness among the rural public additional attention is to be paid to the subject. Hence, one of the most important programs of the Government is the provision of safe drinking water to the rural population.

It is proposed to complete the spill over works sanctioned in NSS,PC1,PC2 Category SC Habitations in the State.

An amount of Rs.42850.00 lakhs is allocated in 2018-19.

#### **32.SKILL DEVELOPMENT, ENTREPRENEURSHIP AND INNOVATION:**

Department of Skill Development, Entrepreneurship, and Innovation promotes and supervises skill developmental activities in a number of areas for a number of people in a variety of sectors. It also promotes various programmes for improving the skill and work on the attitude of people towards work, use of technologies, tools, and machinery to improve the efficiency of operations. The department promotes entrepreneurship and encourages innovation.

It also monitors implementation of various programmes for sustaining and promoting the quality of education with the objective of enhancing employability and promoting innovation driven entrepreneurship to the students particularly those hailing from marginalized sections of the society.

An amount of Rs.12104.00 lakhs is allocated in the year 2018-19.

#### 33.SOCIAL WELFARE DEPARTMENT:

Social Welfare Department implements various schemes for the Educational advancement, Socio-economic development, Welfare and Protection of Scheduled Castes in the state.

#### **JNANABHUMI**

 JnanaBhumi, an integrated smart portal for education and scholarships is designed to cater the needs of education department as well as welfare department.

#### i) POST MATRIC SCHOLARSHIPS:

Post Matric Scholarships is a flag ship programme of Govt. of A.P. for providing total Tution fee (RTF) and maintenance (MTF) to all eligible SC Students who are having the family income of Rs.2.00 Lakhs Per Annum and pursuing studies from ITI to Ph.D. on saturation mode. The scheme is completely operational online and Aadhar authenticated.

MTF to the students is given every month and Tuition Fee (RTF) will be released every quarter in Post Matric Scholarships.

#### ii) PRE MATRIC SCHOLARSHIPS:

Pre Matric Scholarships for the students studying 5<sup>th</sup> to 8<sup>th</sup>class:-

- Pre Matric Scholarships scheme is implemented to improve the retention levels and continuation of their education from upper primary to secondary level.
- Pre Matric Scholarships (Rs.150 per month for girls and Rs.100 per month for boys for 10 months) are sanctioned to the students studying 5<sup>th</sup> to 8<sup>th</sup> classes in all Government / Aided Schools.
- The scheme is made fully online and Aadhar based.

#### iii) PRE MATRIC SCHOLARSHIPS TO 9<sup>TH</sup> TO 10<sup>TH</sup> STUDENTS:

 Pre Matric Scholarships (Rs.150 per month for 10 months and Rs.750 adhoc grant per annum for days scholars and Rs.350 per month for 10 months and Rs.1000 adhoc grant for hostellers) are sanctioned to the students studying 9<sup>th</sup> to 10<sup>th</sup> classes in all Government / Aided Schools.

#### iv) UPGRADATION OF MERIT TO SC STUDENTS:

• Under the scheme an amount of Rs.25,000/- is provided for Merit Upgradation of SC students pursing residential education in Intermediate.

#### v) AMBEDKAR OVERSEAS VIDYA NIDHI (Financial Assistance for Studies abroad):

- With a view to facilitate poor SC Students to go abroad for higher studies, Govt. have introduced the scheme "Ambedkar Overseas Vidya Nidhi".
- Under this scheme, all the eligible SC Students are provided with a grant of Rs.10.00 Lakhs and one way economy air fare and visa fee for pursuing MBBS/Professional PG / Ph.D level studies in Foreign Countries.

#### vi) SKILL UPGRADATION FOR PROFESSIONAL GRADUATES:

Under this scheme coaching for GRE/GMAT/TOEFL/IELTS is given in reputed coaching
institutes to secure admissions in various universities in Abroad and in turn to get
benefitted under Ambedkar Overseas Vidhya Nidhi Scheme

#### vii) NTR VIDYONNATHI:

• Under "NTR Vidyonnathi" scheme Professional Guidance for Civil Services Examination is provided by sponsoring the SC students to reputed coaching institutions in the Country.

#### viii) BEST AVAILABLE SCHOOLS:

 To provide qualitative English Medium education to the SC Students in their Districts, the Best Available Schools scheme is implemented for the students studying 1<sup>st</sup> to 10<sup>th</sup> Classes by providing admission in reputed English medium schools with Residential and Non-residential facilities and the cost of Education is borne by the Government.

#### ix) BOOK BANK SCHEME:

• Under this scheme Text Books and Reference Books are provided for SC students pursuing Professional courses like Engineering, Medical, Agriculture, Law, MBA etc.,

#### x) REHABILITATION SCHEME FOR BONDED LABOUR:

 Rehabilitation of Bonded Labour identified in the Districts is taken up through APSCCFC Ltd. At present an amount Rs.20,000 is given for each released bonded labour by the Social Welfare Department.

#### xi) PROMOTION OF INTER CASTE MARRIAGES:

• Govt. have been encouraging Inter-caste Marriages for Social Integration and Social Reform with an objective of eradication of caste system in the Society by sanctioning an incentive of Rs.50, 000/- Per Couple.

#### xii) A.P.STUDY CIRCLE

- Dr. B.R. Ambedkar Study Circles at Visakhapatnam, Vijayawada and Tirupathi are organising Coaching for SC Unemployees for various Competitive Examinations.
- Under this Scheme, SC students are also sponsored to Reputed Coaching Institutions in the State, for providing guidance for Group-I, Group-IIExaminations.

#### xiii) CONTRIBUTION TO SW FUND:

• To encourage, help and strengthen the registered voluntary organizations which are engaged in Social Welfare activities, financial assistance is provided under the scheme.

#### xiv) REHABILITATION, ECONOMIC DEVELOPMENT, FOR JOGIN WOMEN

 Under the scheme identified Jogin Women are rehabilitated through APSCCFC Ltd by providing the Economic support schemes.

#### xv) BUILDINGS:

 Under the scheme construction of Dr.B.R.AmbedkarSmritivanam project with 125 ft tall statue of Dr.B.R.Ambedkar, memorial park, BuddistDhyanaKendram, multipurpose convention centre, library, open air theatre etc., are constructed.
 Further buildings like AmbedkarBhavan, Community Halls, Integrated Hostels, Colleges Hostels etc., are taken up through APIIC/APEWIDC/APMSIDC/Panchayat Raj Dept.

## xvi) CONSTRUCTION OF COMMUNITY HALLS UNDER PROMOTION OF INTER CASTE MARRIAGES AND ERECTION OF AMBEDIAR STATUES:

• Under the Scheme, community halls are constructed in SC localities and Dr.B.R.Ambedkar Statues are erected.

#### xvii) ASSISTANCE TO NODAL AGENCY FOR IMPLEMENTING SC SUB PLAN:

 As per the SCSP & TSP Act, an Administrative and Technical Support Unit and a Research Cell are established to assist the Nodal Agency to carry out various studies, gap analysis, and designing new schemes etc., and to develop IT initiatives, Decision Support Systems etc. Various activity of the above unitsare funded under Assistance to Nodal agency.

## xviii) JAGJEEVAN JYOTHI (FREE POWER TO SC HOUSE HOLDS UPTO 75 Units per month):

• Under the scheme Social Welfare Department pays the Electricity bill of SC House holdsconsuming upto 75 units of electricity per month whose consumption is not more than 100 units per month.

## xix) SPL. CRIMINAL COURTS DEALING WITH OFFENCES UNDER IPC & PCR AND POA ACTS, AGAINST SCS & STS:

• Special Criminal Courts deals with the offences under IPC, PCR and POA Acts.

#### **XX) MONETARY RELIEF & LEGAL AID TO THE VICTIMS OF ATROCITIES:**

• Under the Scheme relief as prescribed by the Government is paid to the victims of atrocities.

#### xxi) CHANDRANNA PELLI KANUKA:

The Government recognises the need for an intervention that addresses the financial difficulties faced by poor SC families while performing the marriage of girls. In

furtherance of the recognition, the Government proposed to introduce a scheme – ChandrannaPelliKaanuka for SCs, to provide to every unmarried girl belonging to the Scheduled Castes community, at the time of her marriage, a one-time financial assistance of Rs. 40,000/- (Rupees Forty Thousand Only), subject to the eligibility guidelines.

#### xxii) AP SC COOP. Finance Corporation Limited:

- Objective of the Corporation is to provide financial assistance for creation of income generating assets to the poor Scheduled Caste households for their social & economic development.
- Schemes being taken up include Purchase of Agricultural Lands, Bore Wells, Tube Wells, Submersible Pump sets, Pipe Lines, Milch Animals, Energization of Minor Irrigation Schemes, Filter points, Schemes under ISB sector with bank tie-up and various Skill Development Training Programmes with special emphasis on Vulnerable sections like Scavengers / SafaiKaramcharis, Bonded Labour, Flayers & Tanners, Jogins, Self-Employment Schemes under NSFDC & NSKFDC.

#### a). E-payments:

Bank linked schemes through e-payment system of **direct release of subsidy** in**to beneficiaries' loan account** from Head Office from Nov'2013 is implemented.

Accordingly, SC Corporation started implementing the direct release of subsidy through e-payment system.

#### b) OBMMS:

'Online Beneficiary Monitoring & Management System' (OBMMS) software developed with assistance of the Centre for Good Governance (C.G.G) to facilitate transparency, accountability, avoid duplication and curtail the delays in the implementation of the schemes. The OBMMS package is under implementation in all the 13 districts.

#### c) Loan Recovery Tracker:

For sharing the data from Banks, Loan Recovery Tracking module is developed for tracking the recovery data of Welfare schemes implemented by APSCCFC Ltd.

#### d) Geo-tagging of the Grounded units:

After every six months, the Panchayat Secretary/ SHG groups will take geo-tagging photograph of the unit and submit the same to the concerned ED for uploading in the OBMMS portal.

#### e) Web portal for Skill Development Training Programmes:

A separate web site is created (youthwayap.org) for registration of educated SC unemployed youth those who are seeking job oriented / Self-employment oriented trainings to improve their employable skills for getting jobs and to take up self-employment ventures to live in a decent and dignified livelihood. The APSCCFC Ltd initiated a special awareness camps in all the districts motivating and involving with youth and women.

#### f) NSFDC & NSKFDC:

- i) The Government have revived of NSFDC / NSKFDC schemes and high value units are implemented under NSFDC.
- ii) Mechanised cleaning machines to the group of SafaiKaramcharis tie-up with Municipal Corporations will be provided.

#### g) Training Programs for the year 2018-19:

The following training programs are proposed to be given to SC unemployed youth in the following fields:

- 1. Job Oriented High End training programs.
- 2. Placement Oriented training programs.(ChandrannaCheyutha)
- 3. EDP for Entrepreneurs (Ni-MSME, Contractors Development training programs)
- 4. Skill Development Training Programmes (ASTA) (Dr.Ambedkar Skill Development Training Academy)
- 5. National Institute of Tourism and Hospitality Management (NITHM, Hyderabad).
- 6. National Academy of Construction, Hyderabad (NAC).
- 7. Central Institute of Plastics Engineering and Technology, Hyderabad (CIPET).
- 8. Job mela
- 9. Soft skills and English language trainings
- 10. Long term partnerships with non-profit organisation like NITF and others, with proper industry connect
- 11. Tie-ups with CSR funding from corporate sector

#### h) ASTAs:

Ambedkar Skills and Training Academy (ASTA) – The Corporation is imparting placement oriented / skill development training programs to the SC educated unemployed youth for getting either jobs or to establish self employment economic support schemes to eke-out their livelihood in a better way. However, these training programmes are organized through selected outside training agencies.

To construct permanent training centers for conducting Ambedkar Skills and training Academies (ASTAs) continuous skill development training programs to the SC educated unemployed youth on residential basis in each of the District. The lands shall be identified

abutting the highways and prime localities with convenience to reach for this purpose and buildings can be leased out on rental basis, till the permanent infrastructure is created.

The following Training Programs are proposed to be organized in the above centers.

- 1) Placement oriented training programs.
- 2) Coaching to the aspirants of Govt. services/ Banking service /PSU/PSE services etc..
- 3) Skill Development training programme for self employment and
- 4) Training to improve soft skills, like numerical ability, mental abilities, aptitude, analytical, abilities, test of reasoning and English language etc as to complete with other category of candidates in a better way in securing jobs.
- 5) High-end trainings linked to certification and placements.

#### i) Land Purchase Scheme:

Special focus on Land Purchase Scheme with enhanced unit cost up to Rs 15.00 lakhs per beneficiary in (3) slabs

- 1. 3.00 acres of dry land uptoRs 9.00 lakhs
- 2. 2.00 acres of single crop wet land uptoRs 12.00 lakhs
- 3. 1.00 acre of double crop wet land uptoRs 15.00 lakhs

(75% of the unit cost is towards subsidy and 25% Loan) Separate budget allocation is also made in SCC 2018-19.

#### j) High Value Transport Vehicles:

 Providing high value transport vehicles, Innovas and Cars are provided for the SC beneficiaries.

#### k) SPECIAL CENTRAL ASSITANCE FOR SCP FOR SCS:

 Under the scheme subsidy component of various economic support schemes of APSCCFC Ltd, is met.

An amount Rs. 267508.30 Lakhs is allocated in 2018-19 to Social Welfare Department.

## 34.SOCIAL WELFARE RESIDENTIAL EDUCATIONAL INSTITUTIONS SOCIETY GOALS & OBJECTIVES:

With an objective of providing quality education to the children belonging to poor, backward marginalized sections of the Society, separate Residential Schools were started by Government of Andhra Pradesh in the year 1983 under the aegis of AP Social Welfare Residential Educational Institutions Society.

After Re-organization of Andhra Pradesh, [185] Regular institutions have been functioning under the Administrative control of APSWREI Society. The different categories of institutions functioning are mentioned as under:

**TOTAL NO.OFINSTITUTIONS - 185 Nos**(63 Boys, 120 Girls and 2 Co-Education)

Upgraded Institutions with Class V to Intermediate: 151 (46 for Boys & 105 for Girls)

Independent Jr. Colleges with Intermediate : 4 (2 for Boys & 2 for Girls)

Centres of Excellence with Class IX to Intermediate: 2 (Co Education)

Non Upgraded institutions with Class V to X :28 (15 for Boys & 13 for Girls)

The entry for Admissions are made in Class 5<sup>th</sup> and I year Intermediate, every year. Admissions for 5<sup>th</sup> class is through Common Entrance Test and for Intermediate, it is based on SSC marks. Admissions for Class 9<sup>th</sup> in Centre of Excellence are also through Common Entrance Test.

The major objective of APSWREI Society is to provide quality education to the Scheduled Caste students through Residential Schools.

## Some of the new initiatives/programmes being implemented by APSWREIS are as follows:

#### i). Introducing concepts of teaching projects in science and maths:

The Soc1iety has introduced concepts of teaching projects in Science and Maths subjects through the firm M/s Janyaa Foundation by providing Janyaa Science & Maths kits for VI to IX class students of APSWR institutions.

#### ii. Training to the Craft Teachers in tailoring, bakery, saree rolling, etc.,

Provided Training to the Craft Teachers of APSWR institutions in Tailoring basics, bakery items and saree dry wash, rolling and polishing in collaboration with Eenadu during September, 2016.

#### iii) .CuriosityCarnival:

Science Fairs have been named as Curiosity Carnival. The Curiosity Carnival are conducted during September and November months.

#### iv).LittleTeachers:

An innovative concept of live lecture series by Little teachers (Students) on MANA TV has been introduced in the Society. The live classes on MANA TV by the Little Teachers August, 2016 to November, 2016.

#### v). School Radio Programme:

A new innovative initiative project School Radio Programme has been introduced in APSWR institutions from the month of July, 2016 to improve the communication, public speaking skills, skills of research, group discussions, team work etc., among the students.

#### vi) Super Students:

The Society has introduced a novel concept of Super students for students with 100% attendance to improve the regular attendance in all the students. They have been awarded with flight journey to Hyderabad, sight seeing in Hyderabad City for two days and Five Star hotel treatment.

# vii) Summer Sports Camps:

Conducted Games & Sports Meet to encourage the students to participate in State Level & National Level Games & Sports tournament.

# viii).SummerLeadership Programme conducted for Students:

- 1. **Visual Arts Summer Camp**: To instill the inputs in Art & Painting.
- 2. **Music & Dance Camp**: To provide the nuances of the rhythm and melody
- 3. Abacus & Vedic Maths: To introduce Abacus & Vedic Maths
- 4. **Echoes:** To improve English Speaking skills and communication skills among students
- 5. **Robotic & Web Crawler camp:** Teaching the rudiments of Robotics Science and to develop the project based learning.
- 6. **KARATE Camp:** Conducted Karate camp to the girls students
- 7. **Young Leadership Camp:**To improve personality development among the students

#### ix).DasaraCamps:

During Dasara vacation Music camp, Horse riding camp, Dance camp, Karate camp, Spoken English, Computer Basics are conducted.

# x).SandArt:

Providing training in Sand Art (SykataSilpam) to the students to develop their skills.

#### xi). Supply of Dictionaries:

Oxford learner's English Dictionaries have been supplied to all students of APSWRE Institutions to build the vocabulary and to develop communication skills in English.

#### xii).SummerLeadership Programme:

The students tend to unlearn what they learn in the class room during the summer holidays. To bridge the gap students' leadership programmes have been conducted to boost up the morale, aspirations and confidence level among students.

#### xiii).ADVENTURE SPORTS -

#### a) Mount Everest:

APSWREIS has undertaken Mount Everest expedition in 2017 in which (9) students including (2) Girls successfully scaled mount Everest. For the present year, preliminary

selection at School level and district level were conducted and selected students were further trained in Atal Bihari Vajpayee Mountaineering Institute in Manali. A team of (20) shortlisted students were sent to Ladakh to be trained in -30 degrees temperature. It is expected that 12 or 13 out of them will be selected for the final phase of expedition in May 2018

#### b) Guinness World Records:

The Society has broken (3) Guinness records as part of 125<sup>th</sup> Birthday celebrations of Dr.B.R.Ambedkar as shown below:

- o Kolatam dance with 2,315 students in Vijayawada on 06.04.2017
- o 25 hours Marthon relay dance: for 25 hours 2 minutes and 20 seconds on 8<sup>th</sup> and 9<sup>th</sup> of April, 2017 at Tirupathi.
- o Kuchipudi dance with 7,002 students on 11.04.2017 at Visakhapatnam.

#### c) World Memory Championship:

4 students of APSWREIS were selected and represented India in World Memory Championship held in China in December, 2017, sponsored by the Department of Science and Technology.

# d) Mount Kilimanjaro:

In order to promote adventurism and self confidence among the students, the Society has undertaken various activities. A team consisting of (10) Girls and (5) Boys scaled Mount Kilimanjaro, the highest peak in Africa Continent.

# e) National Wrestling Championship:

(2) students (1 girl & 1 boy) from BalayogiGurukulams participated in National Wrestling Championship at Delhi and won Bronze Medals.

#### f) Atal Tinkering Laboratories (ATLs):

With a vision to 'Cultivate one Million children in India as Neoteric Innovators', Atal Innovation Mission is establishing Atal Tinkering Laboratories (ATLs) in Schools across India. ATLs with the support of NITI Ayog were established in (8) Schools in 2017-18.

In the recent round announced by Atal Innovation Mission, of the 131 labs from Andhra Pradesh, 50 labs are from APSWREIS.

Till now a total of 58 APSWR institutions have been selected for setting up of ATLs i.e. 30% of our schools. All the selected Schools will be allotted a budget of Rs.20.00 Lakhs each.

An amount of Rs.105006.43 lakhs is allocated to APSWREIS in 2018-19.

# 35.ENC R&B (STATE ROADS):

An amount of **Rs.2000.00 lakhs** is allocated under Scheduled Castes Component for the year 2018-19 for laying roads.

# 36. ENC R&B (RURAL ROADS):

An amount of **Rs.10.00 lakhs** is allocated for the year 2018-19.

# 37. WOMEN DEVELOPMENT & CHILD WELFARE DEPARTMENT:

Under Women Development & Child Welfare Department the following programmes are implemented during 2018-19.

#### i).Girl Child Protection Scheme:

BPL families having single girl of 0-3 years of age or two girl children of whom the age of second girl child is not more than 3 years are eligible to get direct investment from the Government.

A new scheme of providing special nutrition to address malnutrition among SC pregnant, lactating women and children (an amount of Rs.20000.00 lakhs is provided)

# vi).AnnaAmruthaHastham:

Provide one full meal for pregnant and lactating women at the Anganwadi Centre along with administration of Iron and Folic Acid (IFA) tablets. It is implemented in ICDS projects.

An amount of Rs.46859.87 lakhs is allocated in 2018-19 to Women Development and Child Welfare Department.

# 38.PERSONS WITH DIFFERENTLY ABLED AND SENIOR CITIZENS WELFARE DEPARTMENT:

The Department will provide prosthetic aids like calipers, artificial limbs and hearing aids etc. An amount of **2000.00 Lakhs**is allocated for 2018-19

An amount of **Rs.150.00 Lakhs**is allocated in 2018-19 for providing dresses, instruments for Dalith Artists like Dappulu, ButtaBommalu, Tappetagullu. Puppetry etc.
