It is hereby clarified that on the basis of Act 2 of 1993. Government had issued G.O.Ms.No.212, Finance dated 22.4.94 prescribing conditions for regularisation of services of irregularly appointed people. After the issue of this G.O. as clearly mentioned in para 2/of this order, all earlier orders on regularisation stand annulled. Therefore, any specific G.O. for any category including workcharged employees issued by any department in the Government stand superceded from 22.4.1994, in view of the scheme formulated in G.O.Ms.No. 212 as follow up to legislative action under Act 2 0f 1994

2. The regularisations that are done as per G.O.Ms.No. 212, dated 22.4.1994 is giving the benefit of regularise services to the person concerned only from the date of the issue of the order making it prospective. Therefore, all benefits of regularisation of services will be counted only from the date of the issue of order and it cannot be assumed or presumed on the basis of any earlier order in this regard which stand cancelled (for eg. G.O.Ms.No. 212 of Irrigation & Power Department, dated 22.3.1997 etc.) as already explained in page 25.00 Ms.No. 212 of Irrigation & Power Department, dated 22.3.1997 etc.) as already explained in para above. Hence, cases for counting of services for pension and any other purposes for the period prior to the effective date of regularisation cannot be acted upon.
